

City of Kwinana Story Trees Trail Competition 2022

The Story Trees Trail Competition 2022 is open to all residents of the City of Kwinana under the age of 18 years.*

The competition is in two (2) parts and children are able to enter either one or both parts:

- Part 1 - complete a puzzle by going on the Tree Story Trail; and
- Part 2 - submit an original story about a tree that is special to them within the City of Kwinana (with an accompanying photo of the tree).

The winning entrant for Part 1 shall receive a family voucher to Tree Tops Adventure Dwellingup.

Two winning entrants for Part 2 shall each receive a family pass to Perth Zoo.

Terms and Conditions

- 1) By submitting an entry to this competition, you agree to be bound by these terms and conditions set by the City of Kwinana as the competition organiser.
- 2) Children who wish to enter the competition must obtain a parent or guardian's permission before entering.
- 3) The competition will run from Monday, 11th April 2022 to 5.00pm on Monday, 26 April 2022. **No late entries will be accepted.**
- 4) Entrants to Part 1 must complete the Story Trees Trail and insert the correct answers on the puzzle form (either in hard copy or electronic form).
- 5) Entries may be submitted to the City of Kwinana Administration or Library. Entrants to Part 2 must also submit their entries online through the website www.kwinana.wa.gov.au/
- 6) Entrants must provide their name, age and parent or guardian's name, telephone number and email address. Any special circumstances that the judging panel should consider may be included (on the back of the entry).
- 7) Parents and guardians may assist young children with completing the contact information on their entry form. All entries must otherwise have been completed by the child entrant.
- 8) Only one entry may be submitted by each participant to both Part 1 and Part 2 of the competition.
- 9) The judging panel will include three (3) employees from the City of Kwinana. Judging of entries will take place on 28 April 2022. The decision of the judges is final and no correspondence will be entered into.
- 10) Parents or guardians of successful entrants will be notified by telephone or email on or before 5:00 pm on 5 May 2022.
- 11) The City of Kwinana reserve the right to disqualify any entry as it sees fit and without giving any reason or notice.
- 12) Prizes must be collected by 12 May 2022. In the event that a parent or guardian of a winning entrant are unable to be contacted or fail to collect their prize within 7 days, the City of Kwinana reserves the right to select an alternative winner.
- 13) By entering the competition, parents and guardians consent to winning entrants participating in a photograph shoot as part of the City's publicity for its 'Living Green Promotions'. All identifying personal information will withheld at the specific request of a parent or guardian.
- 14) Although copyright remains with the originator of the story or photograph submitted to the competition, parents and guardians gives a licence, on behalf of their minor child, to the City of Kwinana to copy and reproduce submitted entries for promotional,

marketing and educational purposes. All identifying personal information will withheld at the specific request of a parent or guardian.

- 15) Employees of the City of Kwinana and their immediate families are ineligible to enter the competition.
- 16) The City of Kwinana shall not be liable and excludes all liability (including negligence) for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) for damage to property, personal injury or death suffered or sustained in connection with the competition or the use or taking of any prize except for any liability which cannot be excluded by law including as provided for under the Australian Consumer Law.
