Section 5.65(1) of the Local Government Act 1995 states:

#### 7. PRESENTATIONS TO THE COMMITTEE

#### 7.1 ABORIGINAL BRANDING

**Presenter:** Jade McCallum, Community Development Officer – Arts and Culture

#### **SUMMARY**

The City recently commissioned an artwork to be completed by a Nyoongar artist which celebrates the rich cultural history of Kwinana that can be utilised for various branding and marketing activities. This may include the use of the artwork in a range of marketing and communications collateral including, but not limited to, the revised Reconciliation Action Plan, staff uniforms, car wraps, merchandise, signage, digital and printed marketing material.

Following advice from the Boola Maara Advisory Group the City undertook an Expression of Interest for the artwork, where 8 artists applied. From this 3 were selected to produce concepts. City Staff and Boola Maara representative Cindy Ballard assessed the 3 concepts and selected local artist Tyrown Waigana for the project. Feedback was provided on the concept and the outcome will be presented to the Boola Maara Consultative Committee for information.






# Hero Graphic

# Dambart Karlak


The translation of this title is dambart meaning three and karlak meaning home or camp. 'Dambart Karlak' because there are four sets of three symbols in this design. Being the attributes that identify Kwinana (industry, ocean and flora), the bobtails that always find each other, the boomerangs that always come back and the shields for protection. Karlak becasue Kwinana is a home to Nyoongar people and is a place many returning. This is contemporary design that highlights Nyoonar relationship with place and expresses the City of Kwinana's attributes.


# Boola Dilbi

Boola is the Nyoongar word for many and Dilbi mean living leafs. Many to display the abundance Kwinana has to offer in culture and opportunities. The word for living leafs was selected to reflect the city's growth. It is also a place where Nyoongar culture is celebrated and living as it is home to many Nyoongar residence. As Kwinana is known for its many tree an artwork featuring leafs was fitting. The colours are the secondary colour featured in the Hero Graphic with the introduction of the light yellow which was created to retain constancy in the image.










# **Full Artwork Variants**


These are examples and not limited to the usage of the full artwork. The background art should be placed at a lower opacity that the hero graphic to reduce visual competition. The opacity is to be lowered as needed as long as theres distinction between the two. The background artwork features should always be broader than the features in the hero graphic to reduce visual competition within these pairing. The line work should be thinker in the background art than the hero graphic. The bobtails head should be prioritised instead of its body. Just try to crop the head in because it the artworks reads better.



# Hero Graphic Colour Variants

Within these variation almost every colour except a few blues from the brand guide has been used and graphics can be extracted from these are necessary. Graphics can also be recoloured if needed for example orange bobtails with red line work might be better fitting as long its consistent with the City of Kwinana brand guide.





# Graphics

These graphic can be isolated further and recoloured it needed.

**Bobtails** - An animal found locally and selected for the fact the return to each other as Nyoongar return to Kwinana.

Spots - Markers of place

**Boomerang** - a common traditional tool and instrument selected for its quality to return.

**Core** - The use of the City of Kwinana main colour with secondary colours used with in the artwork.

**Markers** - These are expressions of Kwinana key assets being ocean, industry and flora.

**Shields** - A traditional device used for protection with the Kwinana assets on it.

**Stones** - 17 stones to represent the number of suburbs in Kwinana.


**Site** - A unique shape that holds place for the hero graphic.



# Kwinana Youth Services Early Years

### **Kwinana Youth Services**

Department of Communities funded services that provides case management to Young people aged 12 to 18 who are at risk of, or experiencing homelessness. This service is an individual lead wrap around support to young people to help them identify and address their goals.

**Early Years Development and Support Focus on 5 Key Areas:** The AEDC (Australian Early Development Census) scores evaluate the development of children aged 0-5 across five key areas. This early stage of life is critical for a child's overall development.

**Current Challenges:** Locally, AEDC scores indicate lower levels of development in these areas, highlighting the need for increased support and intervention.

**City's Commitment:** Recruitment of a Permanent Early Years Officer: The City is dedicated to improving these scores by appointing a permanent Early Years Officer to work with service providers to enhance early childhood programs.

**Early Years Action Plan:** We have secured funding to develop an Early Years Action Plan, which will guide our strategies to improve outcomes for young children. The City will also employ an additional Family Support Officer to further increase our team's capacity to support families in the community.

# The Arclight Initiative

# **Summary**

- Launched on 15<sup>th</sup> July with 4 new young people, identified through low school attendance, high suspensions, poor literacy levels and likelihood of re-entering the justice system. All students have had less than 20% attendance previously and 15 suspension per year
- 80% attendance at program since launch
- Coordinated Support Plans currently being designed in partnership with Police, DCPFS, Schools and relevant community organisations
- All young people receive assessments with a psychologist and neuroscientist to investigate neurocognitive components
  (attention, information processing, working memory, executive functioning) that will lead to tailored support plans. This may
  also lead to diagnosis of ADHD, FAS-D, language disorders and other factors that were holding them back.

# Sustainability

- Curtin granted use of initial funds until the end of the year
- DLG contributed funding
- Awaiting response from WAPOL Community Funding, following presentation to grants team in July















#### 8. REPORTS

#### 8.1 APEX PARK UPGRADE

**Presenter:** Sarah-Jane Patton, Community Partnerships Specialist Anoosheh Gohari – Landscape Architect

#### **SUMMARY**

Apex Park is a small local neighbourhood park on Leasham Way, Medina. The City of Kwinana (City) is currently renewing the park. Community engagement has been held via pop-up activations in the park, workshops with the Medina Aboriginal Cultural Centre's (MACC) Elders Group, a play session with the Koya Kids Club, and discussions with residents. The feedback collected has informed the design (see below). We are now looping back to the community to see if we have the design right. The design is being shared via pop-up activations in the park, a stall at NAIDOC Family Day, a workshop with the MACC Elders Group, and discussions with residents. The design includes accessible footpaths, seating, a yarning circle, a frame for a firepit (used for events), resurfacing of the basketball half court, repositioning of the BBQ, nature play, and stage.

The community has indicated that the stumps hold significance as they symbolise the Noongar Six Seasons. During the initial consultation, the MACC Elders Group agreed that relocating the Six Seasons Stumps would enhance the event space and establish a safer play area for children closer to the MACC. However, there is a concern that moving the stumps might cause them to break due to their age and condition, as they are brittle and largely hollow. Since the outcome of the move is uncertain, we are requesting:

Option 1 – move the stumps to surround the nature play. See design.

Option 2 – move the stumps, if they break, incorporate them into the nature play.

Option 3 – if the stumps break and the wood is beyond use, remove it.

The Elders Group has asked that:

- A smoking ceremony is to be held before moving the stumps
- Stage change to a flat surface, as this is better for band/performances
- The City's Traffic Management officers to investigate slowing traffic down on Leasham Way
- Yarning the Six Stumps Tree Story collected
- Artwork on the Six Stumps project to take place after the upgrade
