#### 7.2 DJANDOO MIA CHANGEROOM MURAL DESIGN

**Presenter:** Andrew Frazer of Andrew Frazer Designs

#### **SUMMARY**

Andrew Frazer has been commissioned to create a mural for the new Djandoo Mia Changerooms, Thomas Kelly Oval, Medina. The proposed design is informed by consultations with Nyoongar community leaders and the City of Kwinana, reflecting two key objectives:

- Celebrating historical and contemporary connections to Chalk Hill and the Thomas Oval sporting precinct.
- Providing mentorship opportunities for emerging local artists through collaborative design and creation of a large-scale mural.

The concept aims to foster community belonging and raise awareness of local stories, with further refinement anticipated following youth workshops scheduled for early 2026. Installation of the mural is planned for March/April 2026.

#### OFFICER RECOMMENDATION

**That the Boola Maara Aboriginal Consultative Committee:** 

- 1. Note and provide comments where necessary on the mural concept design proposal; and
- 2. Suggest ways to develop a culturally appropriate process to select young participants for the workshop, ensuring community input, respect for Nyoongar values, and readiness for mentorship.


#### How does this proposal achieve the guiding principle and priority area?




The following mural concept design proposal has been inspired through face to face conversation with trusted Noongar community leaders & the City of Kwinana. This process has been informed by two distinct ambitions:

- 1. To share historical & modern connection to Chalk Hill & the Thomas Oval sporting grounds.
- 2. To provide a mentoring opportunity for young, local artists in designing & creating a large scale mural.

My desire & ambition is to honour both of these pursuits through a honest application that connects the community with a greater sense of belonging & increased awareness around local stories. These visual representations will be further informed by the planned youth workshops to be held in early 2026.

I look forward to receiving your feedback & refining the design in preparation for the installation scheduled for March/April 2026.







#### 7.3 REFLECTION BENCH - NATIONAL REDRESS SCHEME

#### SUMMARY

The Redress Unit within the Department of Justice has contacted the City of Kwinana seeking support to facilitate a memorial bench, or similar installation, in response to a request from a survivor of institutionalised sexual abuse. This forms part of ongoing efforts to provide meaningful acknowledgment and contribute to healing for survivors.

In 2018 the National Redress Scheme was established in response to the Royal Commission into Institutional Responses to Child Sexual Abuse. It acknowledges the widespread sexual abuse of children in Australian institutions, recognises the suffering endured by survivors, holds institutions accountable for the harm caused, and provides survivors with access to counselling, a direct personal response, and a redress payment. The Scheme aims to ensure survivors receive recognition, support, and a pathway toward healing. The Department of Justice facilitates confidential discussions with survivors, and covers the cost of installations, via a cost recovery invoice.

The request involves the installation of a memorial bench and/or a commemorative tree with a plaque within the City of Kwinana, preferably located in the suburb of Orelia. The primary purpose is to create a respectful and reflective space that honours all children impacted by abuse within institutional settings, with a particular emphasis on positioning to support Aboriginal community members.

The survivor has expressed a strong preference for the memorial to be situated in an area that is accessible and welcoming to Aboriginal people. They have also suggested incorporating Aboriginal artwork into the bench design, should this be possible and culturally appropriate.

The Department of Justice has advised that while each Local Government has its own requirements for public installations, they are open to collaboration. They will cover all associated costs once a quote is approved. Their intent is to ensure the memorial is inclusive, culturally respectful, and responsive to the needs and experiences of Aboriginal people in the local community.

The City sees benefit in establishing one bench and reflection point in recognition of survivors and proposes the following:

#### LOCATION

Apex Park -The survivor has requested either a location in Orelia or a suitable location to support Aboriginal community members. Apex, with its positioning close to the Medina Aboriginal Corporation and significance to the community as a central gathering place was considered the most suitable location. With current upgrades at Apex Park the exact positioning will be determined once works are complete. Alternatively, a bench could be located adjacent to the playground next to Fiona Harris Pavilion.

#### **WORDING**

The Department of Justice providing general phrasing for a plaque on the bench such as "This bench is dedicated to all the children who have been impacted by abuse within institutions" The City sees this as an opportunity to integrate child safe, preventative measures with a Buddy Bench and wishes to propose the following wording:



#### Buddy Bench - A safe space to yarn with a mate

This bench is dedicated to all children who have historically been impacted by abuse within institutions. It provides a safe space to connect and helps reduce the risk of future harm.

#### **ARTWORK**

The survivor has requested Aboriginal artwork however it is recommended this be confirmed subject to the suitable bench design for the space. If a mural is suitable that a local artist is engaged to design a mural for the bench that is suitably designed for the purpose of the bench and Boola Maara Aboriginal Consultative Committee are engaged prior to the design phase.

#### OFFICER RECOMMENDATION

That the Boola Maara Aboriginal Consultative Committee:

- 1. Support the reflection bench to be located in Apex Park with the exact design details to be determined via an onsite meeting once current upgrades are complete.
- 2. Support the following wording on a bench plaque:

#### Buddy Bench - A safe space to yarn with a mate

This bench is dedicated to all children who have historically been impacted by abuse within institutions. It provides a safe space to connect and helps reduce the risk of future harm.
