

Request for Alternative Verge Waste Collection Location

If you are unable to leave your green waste or bulk waste on a verge area adjacent to your property for a scheduled collection (this does not include approval for bulk bins or builders verge permits), please complete this form and return to the City of Kwinana Waste Services either:

- In person at the City's Administration Building
- By email to customer@kwinana.wa.gov.au

Examples of when this form should be submitted include:

- where your property has no verge area due to being a battleaxe block or unit;
- where your property has inadequate storage area at the rear of the property to place wastes for collection (such as from a laneway); or
- where your property is located on a hill which makes collection from your verge area unsuitable.

In order to allow access for an articulated loader, your requested collection location must provide at least **1 metre** clearance from any obstructions (For example, fences, reticulation, services, trees, garden structures).

The City reserves the right to allow or disallow a request at its sole discretion where deemed unsuitable.

All other terms and conditions for the collection verge waste are to apply. Visit the Verge Collections section of the City's website for more information.

Any gates that impeded access to the waste must remain open during collection to allow access.

Owners are to ensure that any pets and/or livestock are appropriately secured and do not interfere with the City's officers, employees or contractors whilst they remain on the property.

Forms are to be submit at least 7 days prior to the scheduled verge collection dates in your area to allow sufficient time to process your application.

- I hereby indemnify the City (including its employees and agents) against all liability for any personal injury, illness or death or any loss or damage whether direct, indirect or consequential, arising in any way from my request.
