

Schedule of Fees to Accompany Applications for Trader's Permit

NOTE:

- 1. No fees apply for community, sporting and not-for-profit groups.
- 2. No additional fees apply to trade at approved markets, events and designated trading areas for local food businesses registered with City of Kwinana.
- 3. Expedited service fee of \$174 apply for applications received between 3-10 working days before the approval is required. This fee will apply to applications from community, sporting and not-for-profit groups.

Applications received between 0-2 working days before the required approved will not be approved.
