

## **Checklist for Starting a Skin Penetration Business**

Before you begin:
$\hfill\Box$ Read the Guide to the Construction, Fit-out and Operation of a Skin Penetration Premises, the associated legislations and Code of Practice.
☐ Check if you require planning and building approvals. You are exempt from requiring a planning approval in the Residential area, if you meet the home occupation definition. Refer to the Home Occupation and Home Business Information Sheet. Generally, the following activities are not supported for the exemption in a residential home and will require planning approval:
<ul> <li>involve the retail sale, display or hire of any goods (unless by means of the internet);</li> </ul>
<ul> <li>create repeated, prolonged or loud noise;</li> <li>increase traffic in the street by delivery vehicles or the parking of customer or client cars;</li> </ul>
<ul> <li>occupy an area greater than 20m² and</li> <li>produce smoke, smells, fumes, dust, light, vibration, electrical interferences, waste products and the like.</li> </ul>
☐ Check if you require building approvals. Generally, all works involving structural alternations and additions will require a building permit.
If planning approval is required:
$\square$ Submit a <u>Development Application</u> with supporting information and site plan. Pay the application fee.
☐ Ensure that planning conditions of approval have been met.

If unsure, contact a Planning Officer by phone: 9439 0474.
If <b>building approval</b> is required:
☐ Submit a <u>Certified Building Permit Application</u> with supporting information, site plan and floor plans and pay the application fee
☐ Pay the application fee. Allow for <i>10 working</i> days for processing.

All skin penetration premises will require Environmental Health approval. Please:

☐ Ensure that building conditions from the building permit have been met.

☐ Complete a Notification Form for Skin Penetration Premises with detailed floor plans.  Submit by email to health@kwinana.wa.gov.au.
☐ Complete a <u>Notification Form for Skin Penetration Premises</u> with detailed floor plans.  Submit by email to <u>health@kwinana.wa.gov.au</u> .
□ Pay the inspection fee (invoice will be provided)
Allow 14 business days for assessment. You will be advised by an Environmental Health Officer to proceed with fit-out of your premises.
Just before you are ready to open your business:
$\square$ Ensure that building conditions from the building permit have been met.
□ Submit an <u>Application for an Occupancy Permit</u> and contact a Building Officer to arrange a pre-occupancy inspection, by phone on 9439 0472 or by email: <a href="mailto:building@kwinana.wa.gov.au">building@kwinana.wa.gov.au</a> Allow 3 days advance notice.
□ Contact the Environmental Health Officer to arrange a pre-opening inspection, by phone on 9439 0475 or by email: <a href="health@kwinana.wa.gov.au">health@kwinana.wa.gov.au</a> Allow 3 days advance notice. Environmental Health and Building teams work closely together and will endeavour to carry out the inspection at the same time.
$\hfill\square$ Obtain a notification certificate for skin penetration premises from Environmental Health before you operate
