Terms and Conditions

Entry into the City of Kwinana ('**the City**') *Good Reading Online Competition* ('**the Competition**') signifies acceptance of these Terms and Conditions.

Instructions on how to enter the Competition as well as information contained within promotional material form part of these Terms and Conditions.

1. The Competition opens on **Tuesday, 11 November 2025** and closes at **5:00pm on Monday, 8 December 2025**. No late or incomplete entries will be accepted.
2. To enter, participants must correctly answer a question whose answer can be found in the November 2025 issue of Good Reading magazine and complete the supplied entry form (online or physical copy) with their answer and contact details.
3. Entry is open to any member of the public.
4. Employees of the City and their immediate families or anyone else connected in any way with the competition or helping to set up the competition are ineligible to enter the Competition.
5. Only one (1) correct answer will be eligible to win
6. One (1) winner will be selected at random by the Collection Development Librarian at 10:00am on Tuesday, 9 December 2025.
7. The winner will receive several adult fiction books to the total value of **\$200.00**.
8. The prize is not transferable, exchangeable or redeemable for cash.
9. All prizes are subject to any terms and conditions which may be imposed by the vendor. The City makes no representations or warranties as to the quality, suitability or merchantability of the prizes.
10. The winner will be notified by telephone using the contact information provided on their entry form.
11. It is the winner's responsibility to collect their prize. Any ancillary costs associated with collecting or redeeming the prize are the sole responsibility of the winner.
12. If the winner cannot be contacted to arrange collection of their prize within two (2) weeks of the draw, they will be deemed to have forfeited the prize and a new winner will be selected by the judge at random.
13. Any winner under 16 years of age must provide evidence of parental or guardian permission or be accompanied by a parent or guardian when collecting the prize.
14. All decisions of the judge are final and no correspondence will be entered into regarding the administration, results, or any other aspect of the Competition.
