- 2.Entry instructions form part of these Terms.
- 3.Sticker designs are to be the entrants own original work and must not infringe another parties copyright or intellectual property rights.
- 4.Entries must be received by 4pm, 28 February 2025. Incomplete or late entries will not be accepted.
- 5.Entry to the Competition is open to all persons aged under 16 years.
- 6.Limit of one (1) entry per person.
- 7.The City shall select three (3) prize winners. No cash alternative to the prizes will be offered. Prizes are not transferable. The City reserves the right to substitute any prize with another of equivalent value.
- 8.Competition winners will be notified by via telephone and/or email by the City by no later than 1pm, 11 March 2025. If the winner cannot be contacted or does not claim the prize within 48 hours of notification, the City reserves the right to select an alternative winner.
- 9.Decisions of the City with respect to all matters relating to the Competition will be final and no correspondence will be entered into.
- 10.Competition winners agree to the City taking their photograph at the time of collecting their prize. The City may use their name (either in full or in part) and image in any marketing or promotional material.
- 11.By uploading, publishing, transmitting or making available any data, content or other material in connection with this Competition, entrants agrees to grant the City a non-exclusive, royalty-free, perpetual, irrevocable, worldwide and fully sub-licensable right to use, communicate, reproduce, modify, adapt, publish, publicly perform, translate, create derivative works from, distribute and display in any form, any such content, including but not limited to text, images, videos, graphics, audio and photographs without attribution.
- 12.No personal information collected during the course of this Competition will be provided to any third party without the entrant’s prior consent.
- 13.Except for any liability that cannot be excluded by law, entrants release, and indemnify the City (including its officers, employees, agents and contractors) against, all liabilities (including negligence), claims, actions, costs, losses and expenses on a fully indemnity basis, including (but not limited to) loss of income, damage to property and personal injury whether direct or consequential, foreseeable, due to some negligent act or omission or otherwise, arising out of:
 - a.any act, omission, negligence, fraud, wilful misconduct or breach of these Terms by the entrant, its nominees or agents;
 - b.acceptance of any prize by the entrant, its nominees or agents; and
 - c.the entrant’s participation in the Competition.
